### 2. Personal data that we process

# 4. For what purpose and on what basis we process personal data

#### 6. How long we store personal data

Revenue Sharing/Sales Contracts: 20 years (life time of the OffGridBox)

Mentors/Investors: 10 years

Expression of interest on website: 5 years
